

Yogalution Private Yoga Policies

1. Pricing and Payment

In-home Private Individual Sessions

- \$100 in-home individual rate (Purchase of 5 - 10 session package required upon intake, expires 4 months from purchase/no refunds)
- \$120 One-time private individual session

Studio Private Individual Sessions

- \$80 in-studio individual rate (Purchase of 5 - 10 session package required upon intake, expires 4 months from purchase/no refunds)
- \$100 One-time private individual session

In-home Private Group Sessions

- \$150 in-home group rate (2 to 4 participants – Purchase of 5 - 10 session package required upon intake, expires 4 months from purchase/no refunds)
- \$175 One-time Private Group Session
- \$35 per person for group sessions (5 or more participants)

Studio Private Group Sessions

- \$120 group rate (2 to 4 participants – Purchase of 5-10 session package required upon intake, expires 4 months from purchase/no refunds)
- \$150 One-time Private Group Session
- \$25 per person for group sessions (5 or more participants)

Location

- Studio sessions are held in Yogalution Studio located at:
9590 E Ironwood Square Dr., Suite 125, Scottsdale, AZ 85250
- In-home sessions available in Phoenix and Scottsdale

Private Class Policies:

- All sessions expire 4 months from purchase with no refunds.
- Payment is due at or before the time of the first scheduled session.
- Payment is accepted via cash, check, PayPal or Square (additional 2.75% processing fee applied for PayPal & Square).
- Cancellation policy:
I understand that unexpected situations arise, however, to protect my schedule, cancellations made between 24 and 48 hours of the appointment time will result in a 50% charge of the session. Cancellations made within 24 hours of the scheduled session will result in a full charge of the session cancelled.

2. Client Responsibilities

- Read, understand and agree to the Yogalution Private Yoga Policies
- Complete and sign Yogalution Intake form
- Complete and sign Yogalution Liability form
- Please arrive 5-10 minutes prior to your scheduled studio session or be prepared for your in-home private session 5-10 minutes prior to session start time.
- Wear comfortable clothes that allow for full range of motion. Remove jewelry, hats and socks. Refrain from applying perfume or cologne
- Come prepared with a towel and water

Cancellations:

- Any session cancelled prior to 48 hours before the scheduled session will not incur a fee and can be rescheduled.
- Any session cancelled between 24-48 hours prior to the scheduled session will result in a charge of 50% of the session cost.
- Any session cancelled within 24 hours of the scheduled session will result in a full charge of the cancelled session.
- Client is responsible for the full payment of a session in the event the client does not show up for a scheduled session without prior notice.

3. Instructor Responsibilities

- Rebecca will provide personal liability insurance
- Rebecca will develop yoga programs tailored to the client's needs and desired outcomes
- Rebecca will provide take-home yoga sequences at an additional cost of \$20 per written plan
- Voice or Video recording of the private sessions is available for an additional cost of \$20 per recording
- Rebecca will communicate and confirm the yoga private client policies prior to the start of the first session and will communicate scheduling via email, phone or text message

Cancellations:

- Any session cancelled by Rebecca prior to 24 hours before the scheduled session will be re-scheduled within the week
- Any session cancelled by Rebecca within 24 hours of the scheduled session will be offered within 2 weeks of the date of the cancelled session free of charge

4. Yoga Props

- Mats, blocks, bolsters, straps and blankets will be provided for the client(s)
- Any additional props or preferred props will be provided by the client

5. Documentation

- Client will sign liability waiver and policy form prior to the start of the first session
- Client will complete the yoga intake form prior to the first session
- Rebecca will provide copies of forms for the client upon request
